- 1. To be in possession of a valid medical certificate for the suitability of swimming activities;
- To be in suitable psychophysical conditions for the activity, to have not taken and will not take in the 48 hours prior to the activity narcotic and/or psychotropic substances, to not be under the influence of drugs, to not have consumed excessive amounts of alcoholic beverages and food;
- 3. To respect the provisions given by the Organization in terms of safety, management and travel times, established in the briefing prior to the race;
- 4. To be aware of the foreseeable and unforeseeable risks associated with the practice of the activity even though it cannot be considered a potentially dangerous activity.

I FURTHER DECLARE

- a. To assume from now any and all liability regarding my person, for personal damage and/or damage caused to others (and/or to things) due to my behavior not in compliance with the rules;
- b. For me, as well as for my heirs and/or assignees, to relieve Mare Nordest SSD a r.l. its collaborators and/or employees, as well as their heirs and/or assignees from any liability for injuries, death and/or any damage (even caused by third parties), that may arise to my person on the occasion and due to the activity carried out during the entire event/race of May 25, 2025;



c. To undertake to pay the registration fee of € 150.00 in favor of Mare Nordest SSD a r.l., aware that:

The sum of €30.00 will be retained as an annual membership to Mare Nordest SSD a r.l., including insurance.

I fully understand and share the purposes of these rules established for my safety and that not respecting them may put both me and my companions in a dangerous situation. For the purposes of articles 1341 and 1342 of the Civil Code, I declare that I specifically approve points 1, 2, 3, 4, a), b) and c) of this document.
